KEYNOTE SPEAKER



DAVID ZUCKERMAN LIEUTENANT GOVERNOR OF VERMONT

Lt. Governor David Zuckerman is a father, husband, farmer, former legislator, and the 83rd Lt. Governor of Vermont. He currently lives on his farm in Hinesburg, Vt. with his wife Rachel and daughter Addie. Lt. Governor Zuckerman was born and raised in Brookline, Mass. He moved to Vermont in 1989 to attend the University of Vermont, where he earned his bachelor's degree in environmental studies. While attending university, he was inspired to get involved in politics in 1992 after hearing then-Representative Bernie Sanders speak about economic injustice, standing up for your values and fighting for what is right regardless of the odds. In 1996 he was elected to the Vermont

House of Representatives. During his 14 years in the House of Representatives, he served for six years on the Agriculture Committee with four years as committee chair, six years on the Natural Resources and Energy Committee, and two years on the Ways and Means Committee. In 2012, he was elected as a state senator for Chittenden County, where he served for four years. Lt. Governor Zuckerman served on the Education Committee and was the vice chair of the Senate Committee on Agriculture, where he brought his experience as both a legislator and a farmer to discussions about the future of Vermont Agriculture. As a legislator, he collaborated with activists, advocates, legislators, and everyday Vermonters to organize on a wide array of issues, including leading on marriage equality, cannabis reform, GMO labelling, raising wages, pay equity, renewable energy, medical aid in dying and more. For his work in the legislature, he was recognized as the 2013 Legislative Champion by Renewable Energy Vermont and as 2014 Legislator of the Year by Vermont Businesses for Social Responsibility. In 2017, he served for the first time as Vermont's Lt. Governor. After a two-year hiatus, he returned to the office of the Lt. Governor in 2023, where he plans to build on his previous work and find new creative way to engage Vermonters in the political process. Lt. Governor Zuckerman is particularly interested in addressing Vermont's housing crisis, our planetary climate crisis, universal healthcare, and many more issues relating to economic, social and environmental issues. Outside of his political work, he co-owns and operates his family's organic farm in Hinesburg where they grow and raise vegetables, pigs, eggs and chickens.

PANEL ONE • CULTIVATION INSIDERS

This panel will cover the ins and outs of growing cannabis for adult-use in Vermont, including cultivation practices, state certification, and testing. The panel includes dispensary owners and a doctor from Bia Diagnostics Cannabis Laboratories, which will give a first-hand knowledge of bringing cannabis to market from a business perspective. This panel will focus on the certification process in Vermont, give insight into operating a dispensary, and discuss advocacy initiatives for advancing equity in the cannabis space. Personal knowledge of growing a quality product will pair with the expertise of how to ensure the product is fit for market through bringing to the cannabis industries a well-established protocol for testing found in the environmental, food, pharmaceutical, water, and petrochemical industries.

LECTURE
ENERGY REGULATION AND CONSUMPTION
IN THE CANNABIS INDUSTRY

State legalization of recreational cannabis has led to a boom in cannabis commerce, as well as a significant increase in electricity consumption by indoor cannabis cultivators—up to and potentially exceeding 1% of total U.S. electricity consumption. Consequently, state and local lawmakers have begun to seek and test policy solutions to improve energy management in the cannabis industry. This presentation explores examples of the regulatory requirements enacted by state and local governments to manage or mitigate the electricity consumption of licensed cannabis cultivators. It considers these regulations in the context of social equity, including potential barriers to entry into the cannabis market, and energy equity, including how grid management costs are allocated between cultivators and other ratepayers.

Genevieve Byrne is an assistant professor and staff attorney for the **Farm and Energy Initiative** in the **Institute for Energy and the Environment (IEE)** at VLGS. Professor Byrne holds a JD from Lewis and Clark College of Law in Portland, Ore., where she also received a Certificate in Natural Resources Law. Her experience includes American Farmland Trust, where she worked on agricultural land conservation and legislative research, and the Vermont Office of Legislative Council, where she focused on energy legislation. She has spent the last five years in public interest environmental litigation, representing citizen and nonprofit plaintiffs in suits related to nuclear and solar energy permitting and regulation.

Rodney A. Smolla became the first President of VLGS in 2022. He previously served as dean and professor of law at Widener

University Delaware Law School. He has been a faculty member at the William & Mary, DePaul, University of Illinois, and University of Arkansas law schools, and a visiting professor at law schools at Duke, University of Georgia, University of Indiana, Denver University, and University of Melbourne. Additionally, he has served as the director of the Institute of Bill of Rights Law at the College of William and Mary, and senior fellow and project director of the Washington Annenberg Program of Northwestern University. He currently serves as the chair of the AALS Committee on Academic Freedom

and Tenure and in 2011 he was appointed by the governor of South Carolina as a commissioner on the South Carolina Commission of Higher Education, which included within its mission the oversight of all of South Carolina's public universities and colleges, and licensure and programmatic approval for all public and private educational programs within the state. President Smolla has been and remains an active litigator. He is particularly well-known for his representation of American and international clients on matters relating to defamation and invasion of privacy. He is admitted to the Illinois, Virginia, and Delaware bars, and he has participated as counsel or co-counsel in many litigation matters, in state and federal courts throughout the nation.

Jared Carter JD'09 is an assistant professor of law at **Vermont Law and Graduate School** and formerly the associate director of the Cornell Law School First

Amendment Clinic. He is a graduate of Vermont Law School where, in addition to serving as an editor on the Vermont Journal of Environmental Law, he received an Equal Justice Foundation Fellowship to litigate a First Amendment challenge to U.S. Treasury Department Regulations prohibiting

travel to Cuba. A veteran attorney and advocate for social, legal, and economic justice, Professor Carter was a law clerk to Justices William Leaphart, Jim Rice, and Jim Nelson at the Montana Supreme Court. For more than a decade, Professor Carter has taught and practiced law. He has research and expertise in the First Amendment, Environmental Advocacy, Appellate Advocacy, Movement Lawyering, and Comparative Law.

Timothy Bryon Fair JD'12, Esq. is the founder of Vermont's first cannabis law and consulting firm, **Vermont Cannabis Solutions**. Mr. Fair has been a vocal advocate for both cannabis and overall drug policy reform for most of his adult life. Since becoming an attorney in 2012, he has been fortunate enough to be part of the statewide movement to legalize cannabis in Vermont. He has been featured on a number of podcasts and radio shows, including: two appearances on "The Ganjapreneur Podcast", Vermont Public's "Vermont Edition", Paris Marketing's "Creative Warrior" podcast, as well as a weekly segment on the "In The Weeds" livestream. Mr. Fair has been quoted in multiple national media sources including *The Washington Post*, *Marijuana Business Daily* and *High Times* magazine. He has spoken on the topic of cannabis law at numerous seminars and events across the New England region and was tapped to help design and teach Vermont's first continuing legal education course on Cannabis Business Law in Vermont. When not lawyering, Mr. Fair is an avid swimmer and occasional skydiver.

Dave Silberman is a corporate attorney with 20 years' experience advising founders, executives, and financiers

David Mickenberg is a partner at the Burlington law firm Mickenberg, Dunn & Smith, and has been actively involved

in drug policy reform since 1997. He started his career at the Drug Policy Alliance where he worked on political efforts to reduce the harms associated with the war on drugs, including a multiyear effort to allow Vermonters to access methadone treatment. He currently works on a variety of public policy campaigns including an effort to decriminalize drugs in favor of a public health approach; a push to decriminalize sex work; legislation to increase the rights of working

Vermonters; and efforts to increase benefits and protections for older Vermonters. David played an active role in the establishment of Vermont's medical cannabis program; legislation to decriminalize cannabis; legislation to legalize

home grow, possession of cannabis, and expungement of previous cannabis convictions; and legislation to establish a regulated system for cannabis sales.

TRIBAL REGULATIONS: MEDICINAL CANNABIS AND REGULATORY IMPACTS ON TRIBAL NATIONS

This lecture will explore the impacts of Federal Regulations on Tribal Nations. Using the White Earth Band of Ojibwe's Medicinal Cannabis regulatory scheme as an example, the lecture explores tribal Law, regulatory Issues, and the importance of Tribal sovereignty.

Lisa Brunner is a citizen of the White Earth Ojibwe Nation and is Wolf Clan. Currently, she is chair of the **Medicinal Cannabis Control Commission** for the White Earth Band of Ojibwe. She is also a professor of Anishinaabe Culture at the White Earth Tribal and Community College. Ms. Brunner has worked in the domestic violence and sexual assault field for over 23 years and was the executive director of Sacred Spirits First Nations Coalition whose work addressed violence against Native American and Alaska Native women. Sacred Spirits First Nations Coalition is responsible for the creation of the Harm Reduction Program on the White Earth in its response to the heroin epidemic and has since become a model for Tribes and States. Ms. Brunner has advocated on the local, state, national and international levels to bring about change to public policy to address violence against Native women, men, and children. At the international and national level, she has served on numerous panels and groups addressing

jurisdictional issues that impact the safety of Native women, men, and children. This includes service at the United Nations, including five years at the Permanent Forum on Indigenous Issues, participation in the Global Indigenous Women's Caucus, and a panel on violence against Indigenous Women of North America. Recently she was invited to the Addressing Hate Crimes against Indigenous Peoples: Expert Meeting on the Situation in the Office for the Democratic Institutions and Human Rights, in Vienna, Austria. She has testified on "Violence Against Native Women in the United States" before the Inter-American Commission on Human Rights. Ms. Brunner has also testified before the U.S. Congress on "Combating Human Trafficking: Federal, State, and Local Perspectives" for the Committee on Homeland Security and Governmental Affairs. Additionally, she is a founding member of the National Congress of American Indians, Violence Against Women Task Force and a Bush Foundation Fellow. She has been featured in publications such as "The Inter-American Human Rights System-Handbook", *National Museum of American Indians Magazine*, and *Restoration Magazine*, and is published in the journal, *Psychology of Violence*.

PANEL FOUR • VERMONT CANNABIS LEGISLATION

This panel will include two members from the Vermont Cannabis Control Board (CCB). James Pepper JD'14 currently chairs the Cannabis Control Board. Prior to joining the board, Chair Pepper served as a

deputy state's attorney for the Department of State's Attorneys and Sheriffs. In this role, he advocated for and helped implement many of the criminal justice reform initiatives of the past five years, including expanding expungement eligibility and automatic expungement for cannabis convictions, justice reinvestment, bail reform, use of force standards for law enforcement officers, and raising the age of juvenile jurisdiction. He helped to create systemic and sustained change in Vermont through his work on the Racial Disparities in the Criminal and Juvenile Justice System Advisory Panel, the CHINS Reform Advisory Panel, the Juvenile Justice Advisory Panel, the Act 148 Working Group, the Marijuana Advisory Committee, and the Sentencing Commission. Chair Pepper also worked for Governor Peter Shumlin as director of intergovernmental affairs and senior policy advisor. In this capacity, he developed the statutory framework of S.241 (2016), the first cannabis tax and regulate bill to pass either chamber of the Vermont legislature. Chair Pepper received his BA in Political Science from Johns Hopkins University and his JD from Vermont Law School. He met his wife Aly while working for the Democratic National Committee in Washington, D.C. After deciding they wanted to relocate to the best place in the world to raise a family, they moved back to her home state of Vermont where they currently live with their twin boys Beau and Wesley.

He was worked closely with Agency of Commerce and Community Development (ACCD) as a liaison between agencies to facilitate policy and economic discussion throughout Vermont's agricultural portfolio. 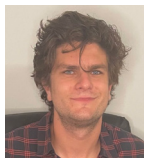
MATTHEW BIRONG

Through that project, and for the next several years as a staff attorney at Vermont Legal Aid, Ms. O'Reilly mastered expungement law in Vermont, lobbied for legislative change to expand the scope of expungement law, and spearheaded the creation of statewide expungement clinics done in partnership with the Attorney General and local prosecutors. Additionally, she developed a collaboration with Code4BTV, a local coding brigade that streamlined the expungement petition-generation process, which ultimately allowed for exponential growth in the expungement filings in Vermont from 2018-2022. She is deeply passionate about access to justice and the rights of all Vermonters—especially those caught in the criminal-legal system. Ms. O'Reilly believes that our systems must do more to reintegrate into our economy and community those who have been involved in the criminal legal system and have served their sentences. Expungement of criminal records after sentence completion is a necessary precondition for meaningful reintegration.
